The following is a supplement to the original report taken on 11-12-2016.

**Continuing Investigation:**

All search warrants have been executed in regards to this case. I have obtained the information contained in William's phone, as well as the phone records from Verizon. All records indicate that William was not using his phone prior to, or during the collision. The last phone call prior to the collision was at 0959 hours. The next phone call was at 1744 hours, after the collision occurred. The last text message prior to the collision was at 1221 hours. There were no text messages sent or received after the collision occurred.

Officer Johnson #536 has completed his reconstruction of the collision and determined a speed range for the vehicle that William was driving at the time of the collision. Based upon his calculations he determined that the vehicle William was driving was traveling between 43mph and 52mph at the time of the collision. Refer to his supplemental reconstruction report for further information.

William's MVD records were also checked in regards to his drivers license suspension. It shows that in June of 2013 William had his drivers license suspension as a result of a conviction of Driving Under the Influence.

Records indicate that he became eligible for license reinstatement in December 2013. William had a new valid drivers license issued in June of 2014. Along with his license reinstatement William was also required to carry an SR22 as a result of his DUI conviction. In March of 2015 William's license was suspended again for a violation of the SR22 requirement, and still showed the suspension for financial responsibility only at the time of the collision.

Based upon all of the information obtained during the investigation this case will be sent to the County Attorney's office for review.
